

# WVHC-TV Being Sold To Washington Post

Travellers Corp. is selling its television station, WVHC-TV, to the Washington Post Co. for \$24 million.

A 14.4, Travellers announced Monday it is selling its radio stations, WVHC and WVHC-TV, and expects to be paid \$20 million for them, making the total cash purchase price for all three stations \$64 million.

It is certain that the Washington Post Co. will buy the radio stations because Federal Communications Commission (FCC) prohibits acquisition of both VHF television and radio stations in the same market.

Negotiations Preliminary

Travellers did not identify the potential buyers of the radio and television stations and it was indicated that negotiations were in preliminary stages.

There is now talk that the radio stations are to be sold to the television outlet, or vice versa.

"The 'W' in the call letters, WVHC-TV, indicates the station is east of the Mississippi River."

The call letters, WVHC-TV, first heard in 1954 when the radio station began broadcasting.

Channel 3 began transmitting in 1957 as an independent station and became affiliated with the CBS television network in 1964.

The radio stations are affiliated with the NBC network.

**Broadcast Plans**

The radio and television stations are operated by Travellers Broadcast Plans Inc. a wholly owned subsidiary of Travellers.

Plans include the purchase of several buildings in downtown Hartford including the 11-story, modern broadcast house, the WVHC-TV building, and the WVHC-TV transmitter site in Avon.

The station is also to be included in the sale to Washington Post Co.

**SAN ANTONIO, Tex. (AP)—**Lyndon Baines Johnson, whose presidency in the turbulent 1960s launched the nation on a course of averting domestic reform but festered on the war in Vietnam, died Monday.

The 64-year-old Texas, who had a history of heart trouble dating back to 1955, was taken ill at his ranch in Johnson City, Tex., and was rushed to Brooke Army Medical Center here, an aide said.

He was pronounced dead at 7:43 p.m. EST at St. Elizabeth's International Hospital by Johnson City physician identified as Dr. David J. Abbott.

President Johnson's cardiologist, Dr. William B. Gaudin, said the cause of the death appeared to be coronary thrombosis.

An autopsy was performed by Dr. George H. Hinkle, Jr., Col. L. H. Heger, chief of pathology at Brooke. The autopsy showed that Johnson had severe coronary artery disease with complete occlusion of three major arterial supplies.

The third major artery was about 90 per cent occluded. Coronary artery disease was said to have caused the heart failure.

# Two Abortion Laws Erased by High Court

WASHINGTON—The U.S. Supreme Court ruling on two state abortion laws is expected to give a high court precedent on the constitutionality of the nation's new abortion statute.

The high court stopped just short of ruling as it ruled Monday that authoritarian states may not pass laws that restrict abortion in both Texas and Georgia.

The thrust of the ruling was that the states must not enact laws that restrict abortion in a way that is not a direct result of the right to privacy established in the first three months of pregnancy.

The court insisted that the decision, however, does not constitute an absolute right to abortion.

The seven-member majority said that it was unnecessary to decide "the difficult question of when life begins."

But it stressed that any state law that limits abortion is not constitutional if it is not a direct result of the right to privacy established in the first three months of pregnancy.
